## **NEW REPORT HIGHLIGHTS LONG-TERM CARE WORKFORCE CHALLENGES**

The Workforce Board has issued a new report that outlines the workforce challenges in caring for Washington's aging and vulnerable populations, including attracting and retaining quality long-term care workers, many of whom confront burnout and financial pressure in pivotal, frontline jobs. Average turnover is high at about 50 percent for direct care workers. Nearly half of home care workers received public assistance in 2020. In addition to identifying pain points, the Workforce Board is leading the discussion of solution-finding, including piloting the state's first ever Licensed Practical Nurse (LPN) apprenticeship—providing a high-skill, high-wage pathway for front-line care workers. ## WA COMMUNITY & TECHNICAL COLLEGES TO OFFER NO-COST OPEN TEXTBOOKS

The Washington State Board for Community and Technical Colleges (SBCTC) recently received a \$2.1 million grant from the U.S. Department of Education for a three-year initiative to expand the number of free introductory textbooks for students in professional-technical programs. College faculty members and SBCTC open education

experts will use the funds to create a set of seven open textbooks for programs in internet technology; forensic science; computer-aided design; health, safety, and nutrition; computer numerical control machining; culinary math; and periodontics. It's part of SBCTC's "Washington Open ProfTech" project, which involves developing open textbooks to prepare students for some of the highest-demand jobs in Washington. ## ANEW TAKES ON NEW FINANCIAL AID ROLE FOR APPRENTICESHIPS

ANEW has taken on a new role as the third-party servicer of the Washington Grant for Apprenticeship (WG-A) in partnership with the Washington Student Achievement Council (WSAC). In this role, ANEW will serve as the financial aid office for income-

eligible apprentices in WSAC-approved registered apprenticeship programs, also known as "Sponsor" programs. Through WG-A, apprentices can receive up to \$4,466 in training funds to cover apprenticeship costs like tuition, fees, and materials. For income-eligible apprentices, there is also potential for an additional \$500 in funding through the Washington Bridge Grant. ANEW will support apprentices in the initial application process, oversee the disbursement, tracking, and notification of awards to eligible apprentices, manage reporting, and more. ## MARKLE REPORT INCLUDES CAREER BRIDGE CASE STUDY

The Markle Foundation has issued a report "Using Data to Strengthen Workforce Training" that includes a case study focused on Career Bridge (see page 18). This report takes a critical look at how other states handle their Eligible Training Provider Lists (ETPL). These lists, required by the U.S. Department of Labor, feature in-demand education programs eligible for federal training dollars. Washington is highlighted as a state that is improving its nationally recognized career-and-education exploration platform, Career Bridge—also home of Washington's ETPL. The Workforce Board is leveraging an additional \$1.4 million in legislative funding from the 2023 session to continue modernizing this public-facing tool that is used in K-12 classrooms and WorkSource centers across the state. ## APPRENTICESHIP TRAINING CONNECTED WITH SAFER WORKPLACES

A first-of-its-kind study from the Washington State Department of Labor and Industries concludes that apprenticeship program growth could reduce serious worker injuries and workers' compensation claims. The results of the study come at a time of expansion for registered apprenticeship programs in Washington. There is record involvement, with 22,000 workers currently participating in apprenticeships across about 200 registered programs in the state. While construction trades such as carpenter, ironworker, and electrician have the most active participants, there are growing programs in the high-tech, aerospace, and medical assistant fields. ## **ERDC LAUNCHES P20W DATA SYSTEM STUDY**

The state's Education Research and Data Center has launched a P20W Data Systems Study to see if there are opportunities to improve the technical tools and processes used to collect, organize, store, and prepare P20W data for analysis. ERDC houses a statewide longitudinal data system of information on Washington students, including data about their experiences from preschool to Grade 20 to the workforce (P20W).
