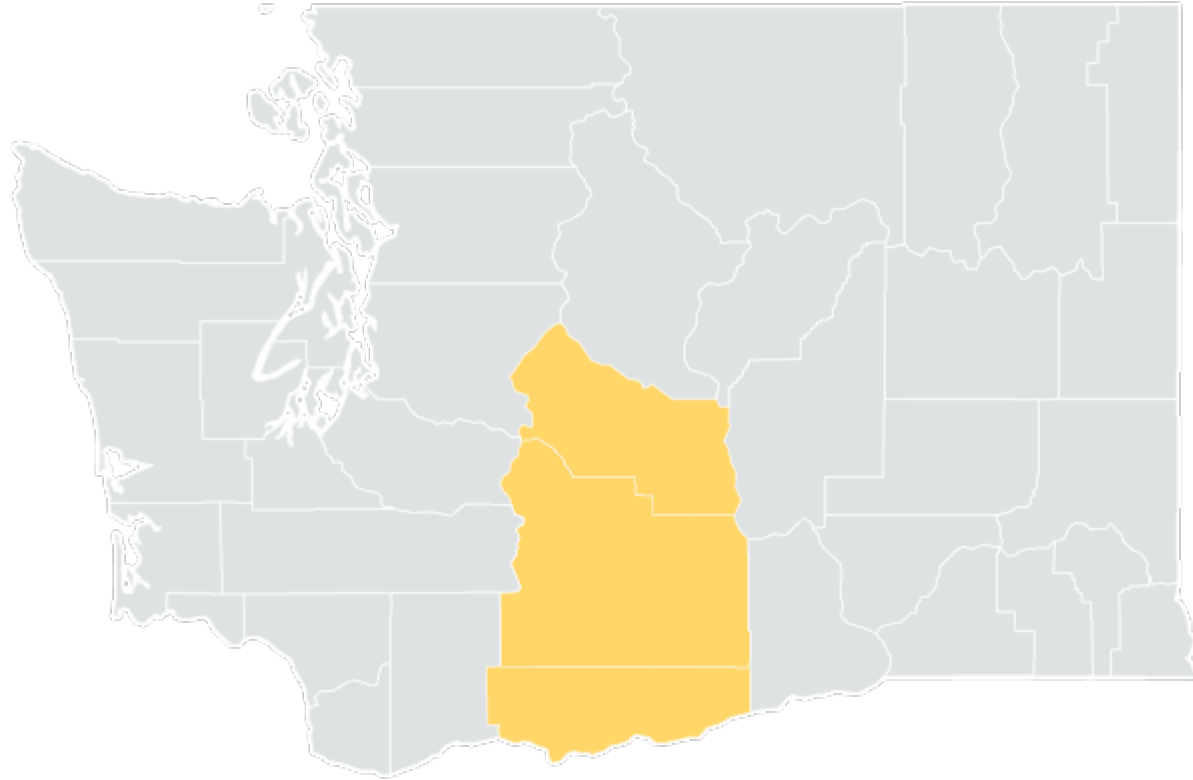


- Challenges to rural reporting are due to limitations in sample size

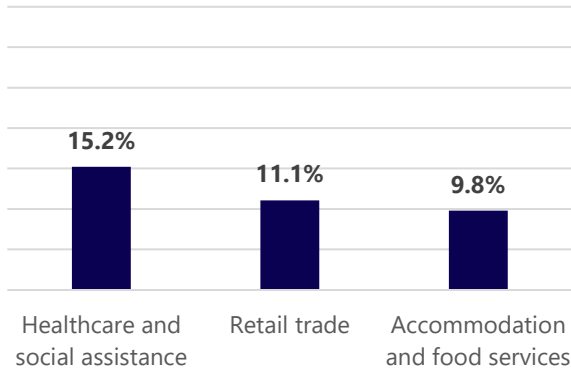

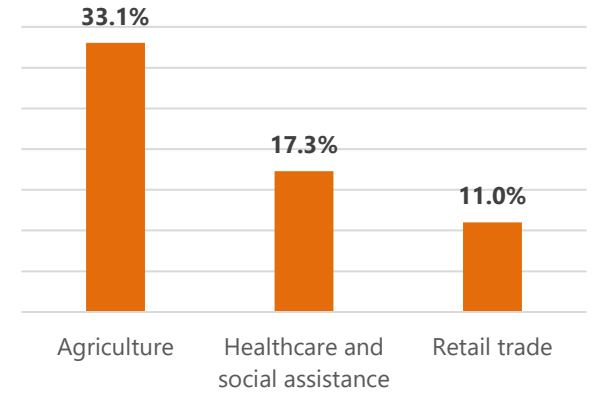
Top 3 Industries by Employment, Washington State, 2023

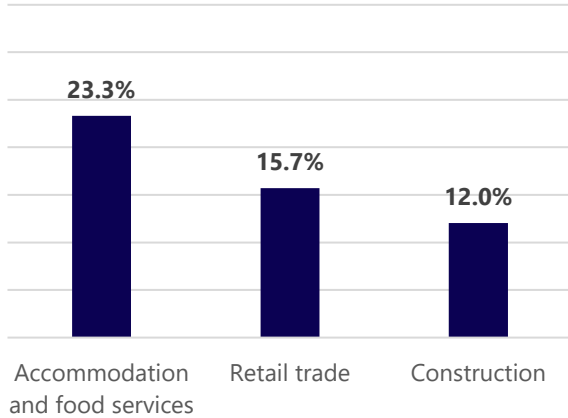

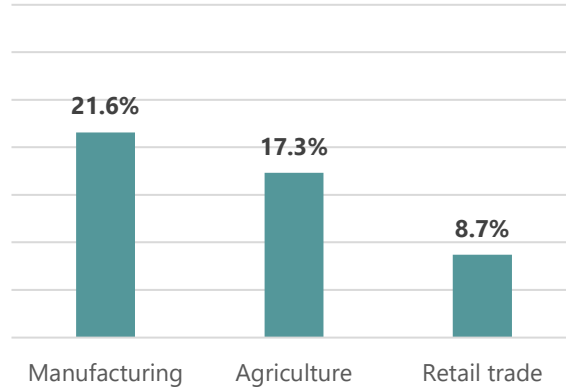

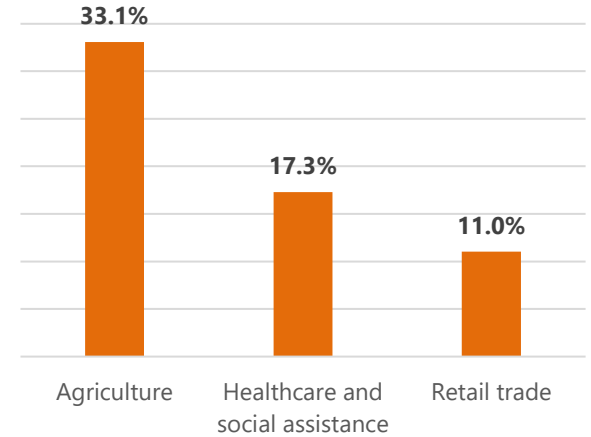
Top 3 Industries by Employment, Kittitas County, 2023

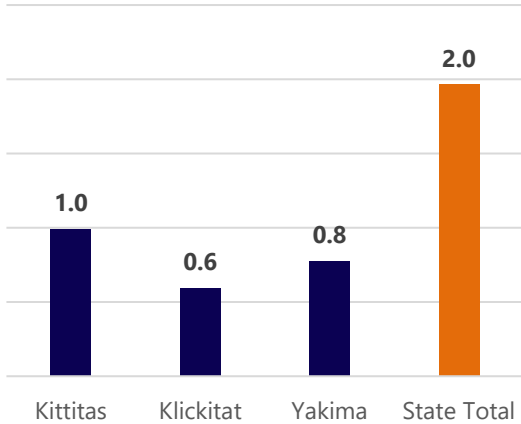

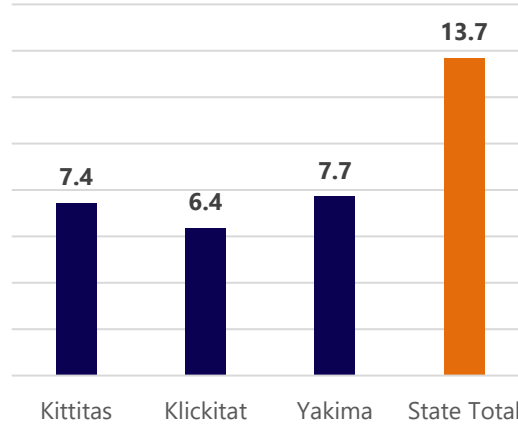

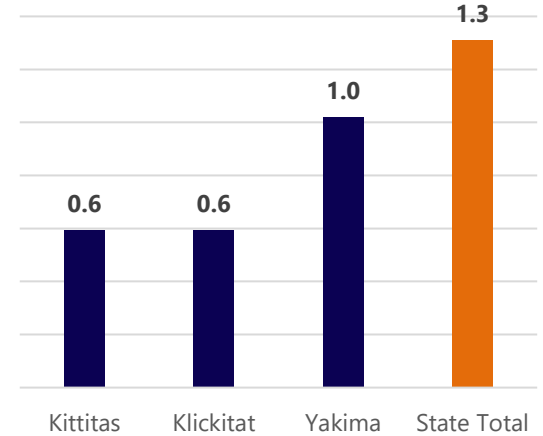
### Advanced Registered Nurse Practitioners per 1,000 People

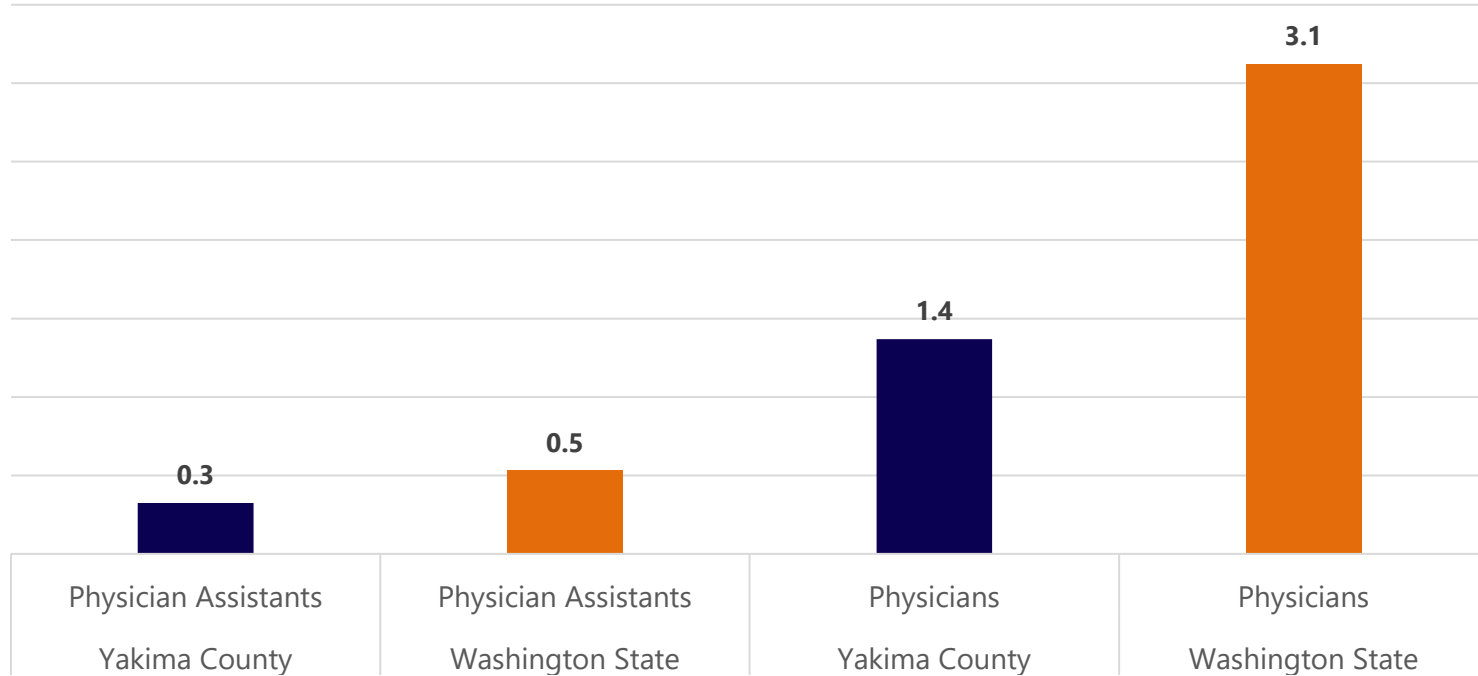

Physicians and Physician Assistants per 1,000 People

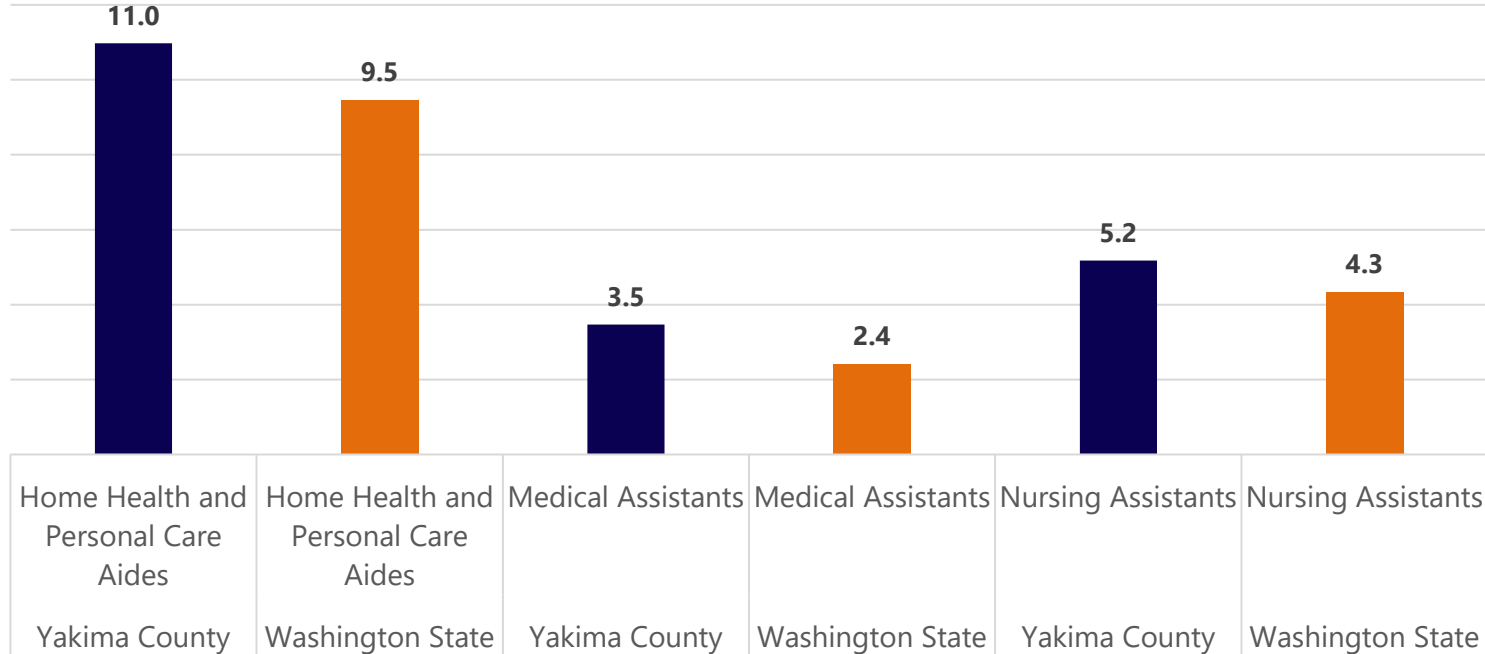

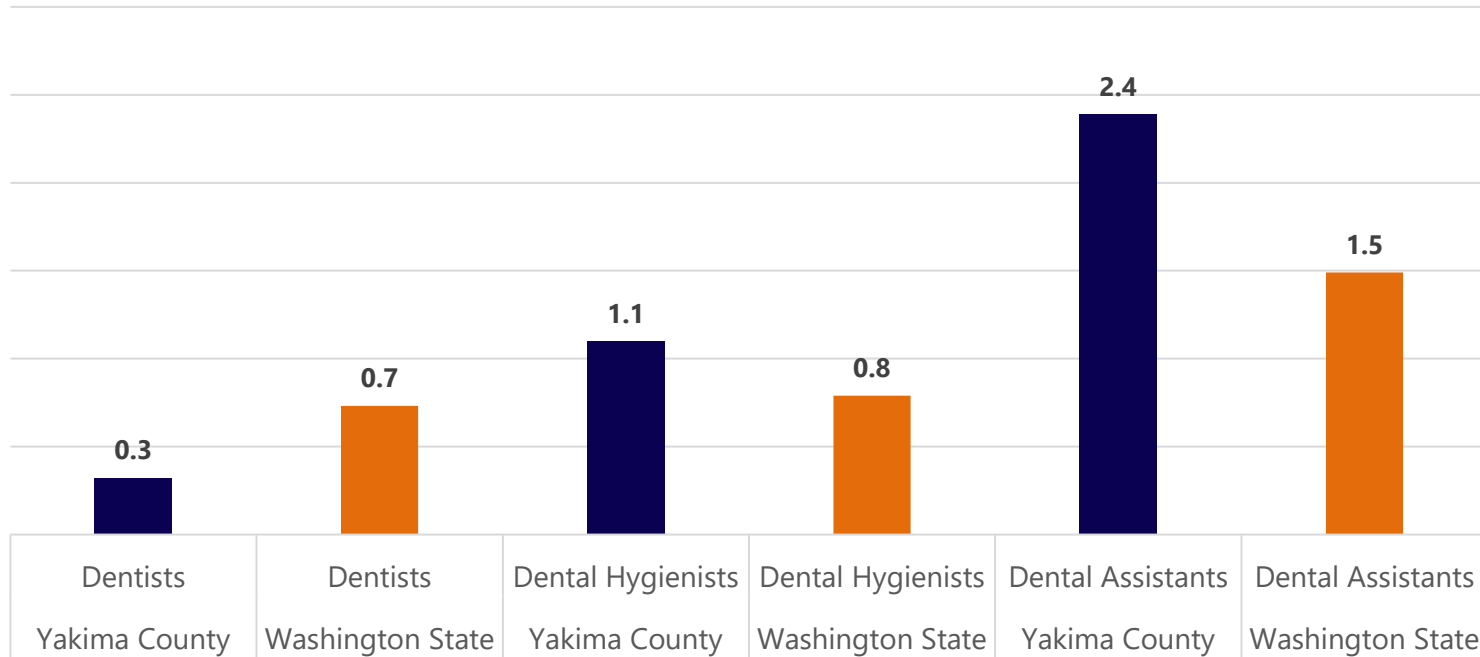






# Dental Occupations per 1,000 People

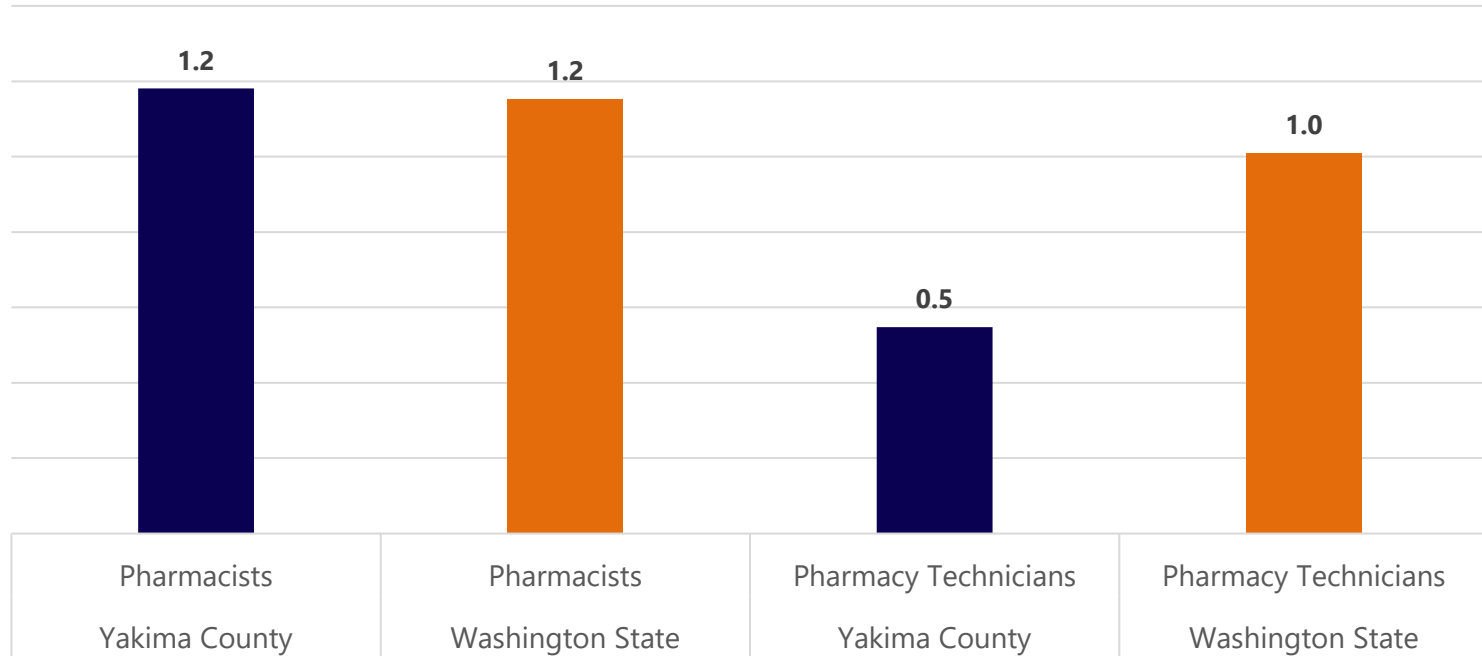

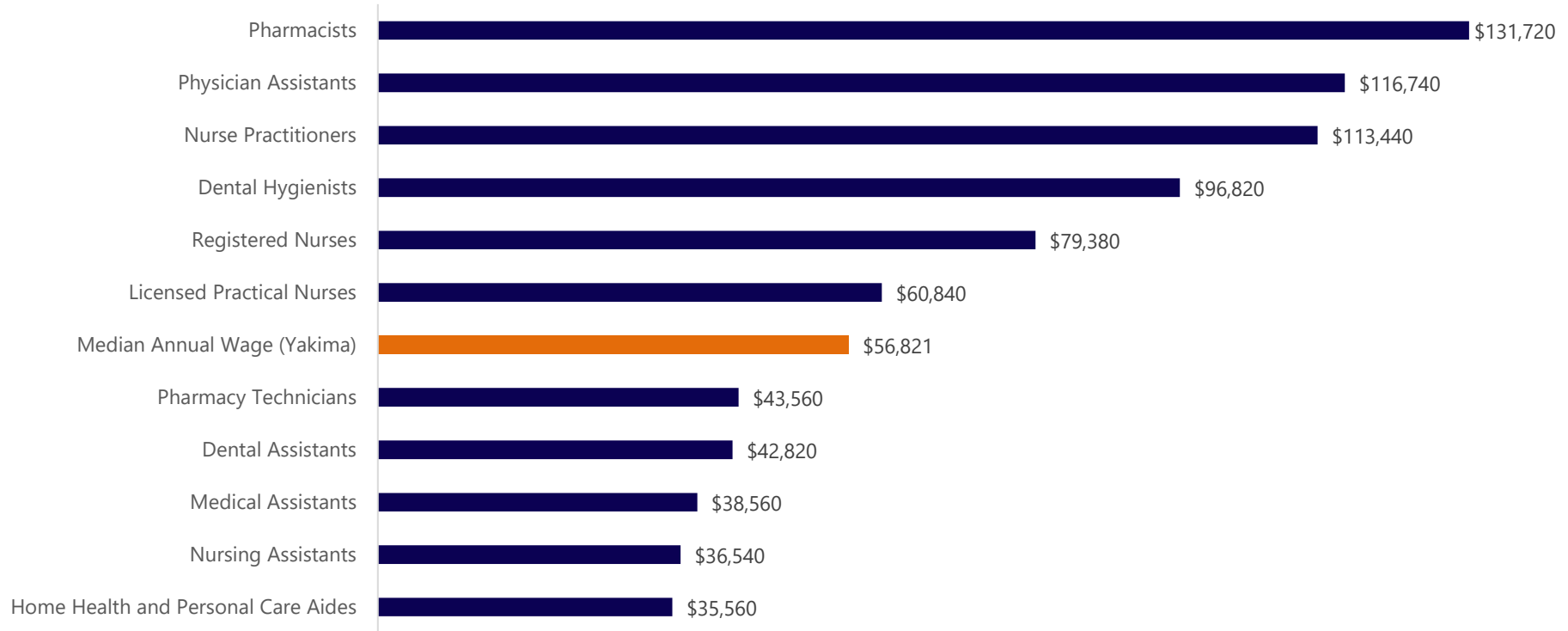

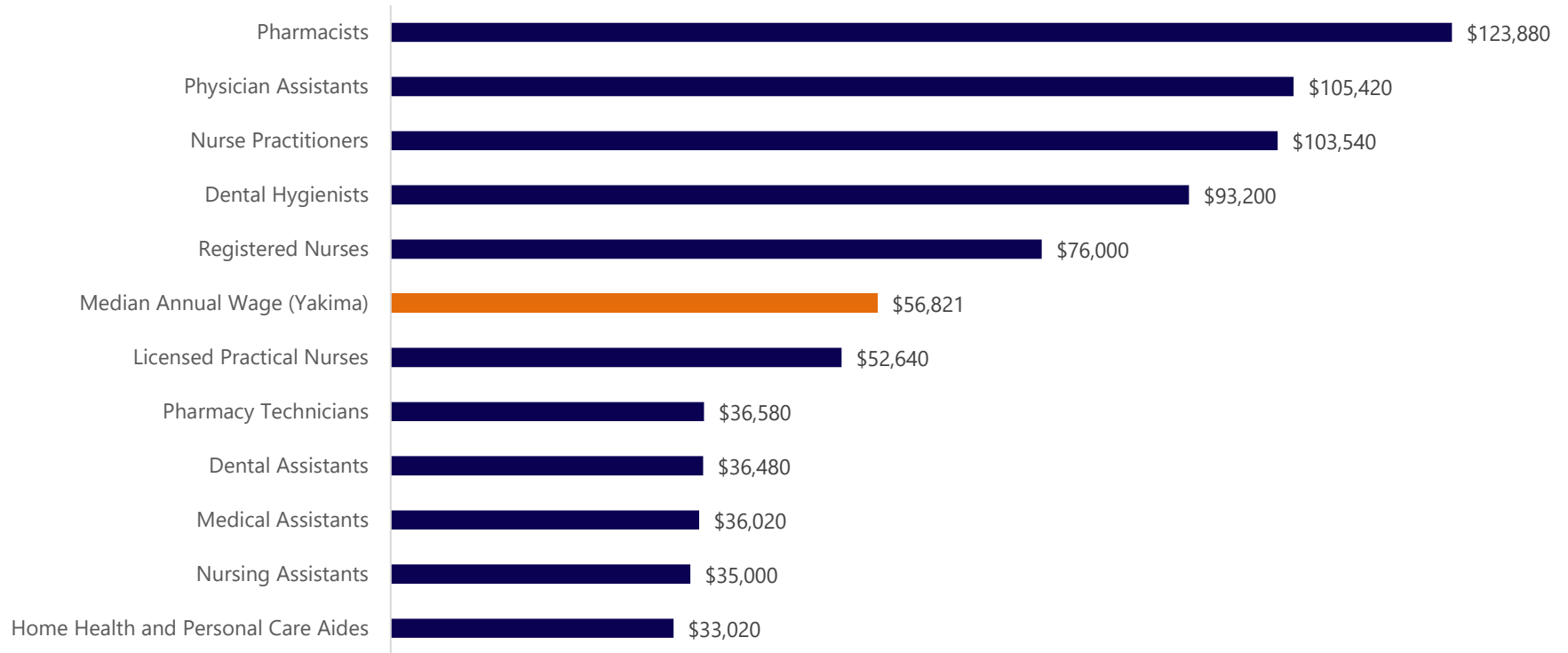
# Median Annual Wages

# 25<sup>th</sup> Percentile Annual Wages

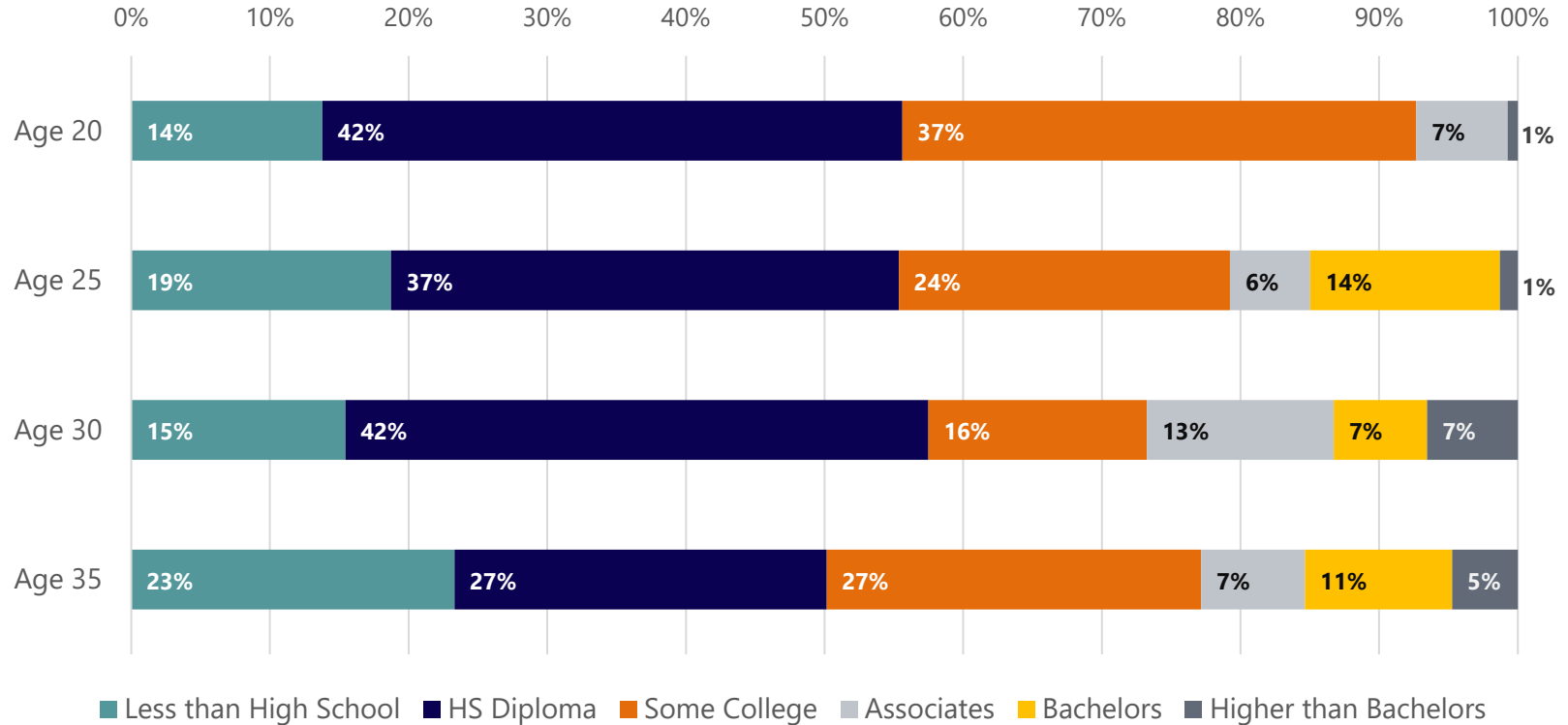

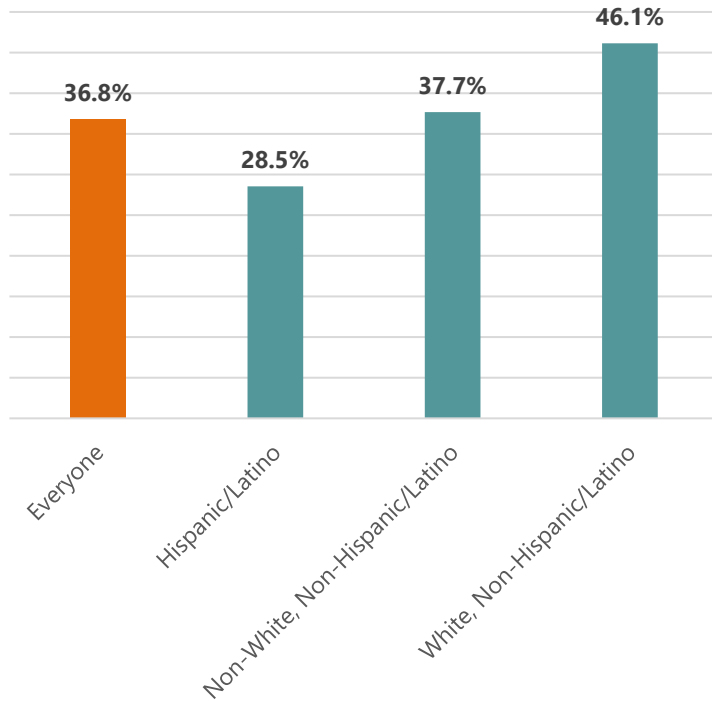

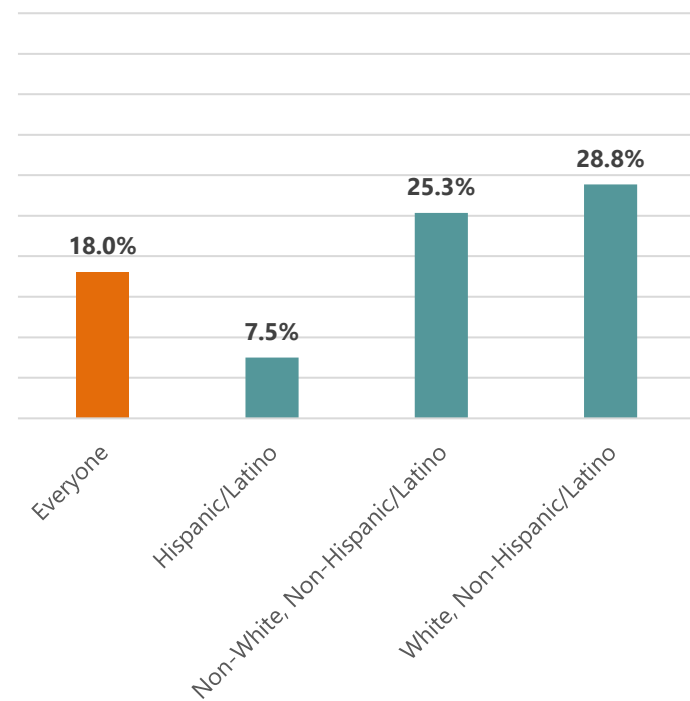


# Highest Level of Educational Attainment

## High School Diploma or Equivalent



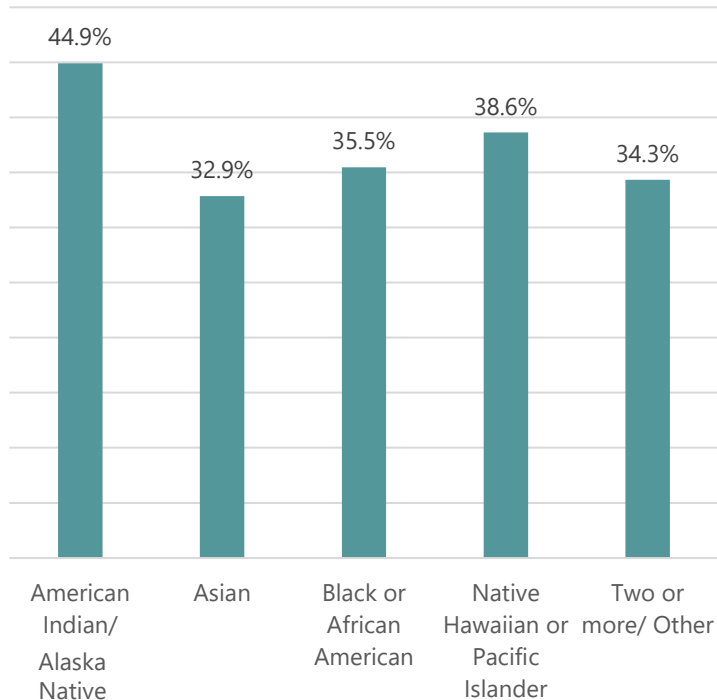

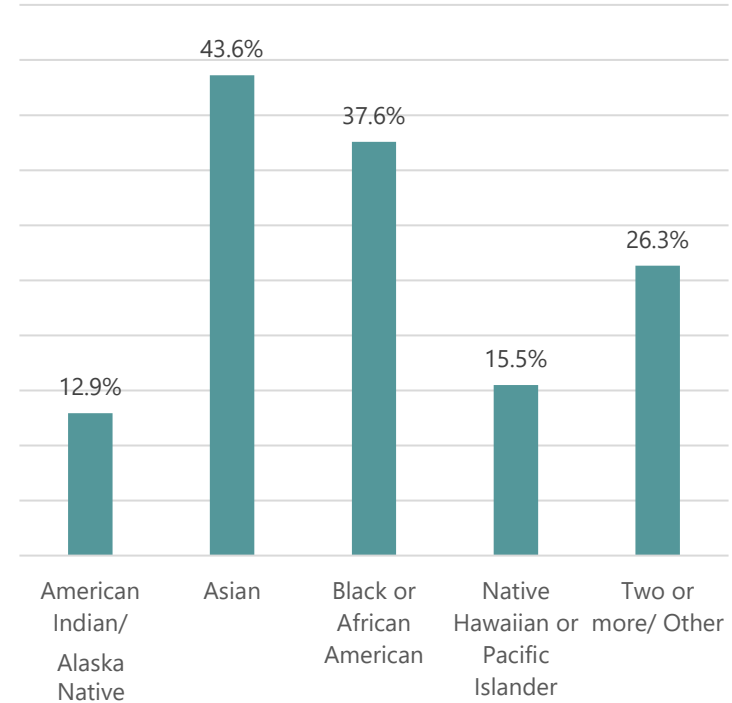


# Highest Level Attainment Breakout
